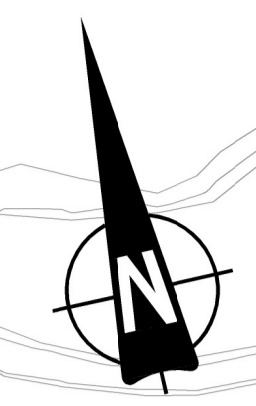


Key Map
